Terms and Conditions

1. All rates should be typed or handwritten on the firm letter head and be signed by the owner of the firm or duly authorized person.
2. Supply orders/work orders from any Government offices which have been supplied with the vehicles on rate contract for last two years may be enclosed.
3. Any supporting document of the firm which shows to genuineness in such dealing.
4. Copy of the Income Tax Certificate of the firm for the current financial year may be enclosed.
5. The rates should be including of all Taxes/Charges and conditions details, if any clearly be indicated.
6. The contract will be up to 31.03.2015, however, AFRI may extend the contract period beyond this date.
7. In case once, the rates are accepted by competent authority of AFRI, Jodhpur, the contract rate will not be subject to increase by the firm in any circumstances.
8. Successful firm has to deposit refundable security amount **Rs. 10,000/-** through Demand Draft in the name of Director, AFRI, Jodhpur. In case of violation of terms and conditions of contract the security amount in full or part as decided by the Director can be forfeited. No interest shall be payable to the firm in respect of the security deposit submitted by him.
9. Boarding and lodging of Driver/Khalasi will be arranged by themselves or the firm.
10. Toll tax/parking charge/Border tax etc. will be paid extra by the AFRI on production of receipts.
