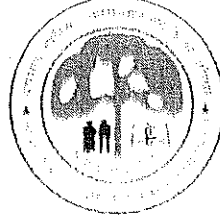



Indian Council of Forestry Research and Education (ICFRE), an autonomous body of the Ministry of Environment and Forests, Govt. of India, invites application from amongst the eligible officers/officials under Central Government, State Government, Public Sector undertakings / Autonomous bodies / Statutory organizations for filling up one post of Hindi Officer on deputation including short term contract in the pay scale at Level 10 of Pay Matrix at Forest Research Institute, Dehra Dun.

Eligibility :

Officer from the Central Government/State Government/Government Undertaking/Autonomous body possessing following educational qualification:-

Master's degree from a recognized University in Hindi/English with English/Hindi as compulsory/elective subject or as medium of examination at degree level;

OR

Master's degree from a recognized University in any subject other than Hindi/English, with Hindi and English as compulsory/elective subjects or either of the two as medium of examination and the other as compulsory/elective subject at the degree level;

OR

Master's degree of a recognized University in any subject other than Hindi/English, with Hindi/English medium and Hindi/English as a compulsory/elective subject as medium of examination at degree level;

OR

Bachelor's degree of a recognized University with Hindi and English as compulsory/elective subjects or either of the two as medium of examination and the other as a compulsory elective subject, plus a recognized diploma/certificate course in translation from Hindi to English and vice-versa or two years experience of translation of work from Hindi to English and vice versa.

(1) holding analogous posts or

(2) with 8 years regular service as Jr. Hindi Translator in the pay band-2: Rs.9,300-34,800/- plus grade pay Rs.4200/- (pre-revised) and possessing educational qualification as stated above.

Tenure: The tenure shall ordinarily be 3 years or till superannuation, whichever is earlier. The tenure is, however, liable to be terminable at an earlier date or extendable at the discretion of appointing authority/cadre controlling authority.

GENERAL INSTRUCTION

1. Applications with complete bio-data together with a fee of Rs.200/- (Rupees Two hundred only) in the form of Demand Draft drawn in favour of **the Accounts Officer, ICFRE** should reach the office of the Secretary, Indian Council of Forestry Research and Education, P.O. New Forest, Dehradun on or before **28.02.2018**.
2. The closing date of receipt of applications from candidates residing in Andaman & Nicobar Island and Lakshadweep will be **15.03.2018**.
3. Application and the envelope should be superscripted as "**Application for the post of Hindi Officer**" against Advt.No.1/Hindi Officer/2017-ICFRE". Applications incomplete in any respect shall be summarily rejected.
4. In no case the Council will be responsible for non-receipt of application or any delay in receipt thereof on any account whatsoever. No application received after the stipulated last date will be entertained under any circumstances and all the late applications will be summarily rejected.
5. The candidate must submit their application through proper channel. The concerned department/organization should enclose vigilance clearance report and Annual Confidential Reports of the officer for the last five years while forwarding the applications of the candidates. However, an advance copy can be submitted along with the prescribed fee.
6. The Council reserves the right to relax, the qualifications/experience in case of exceptionally qualified and meritorious candidates.
7. The Council reserves the right not to fill up the vacancy advertised if the circumstances so warrant in the interest of the Council.
